NARRATIVE AND WITNESS STATEMENTS:

On 06/16/2021 Officer Diaz #3186 assigned to the Westside Regional Command desk assisted the victim with a walk in report. Officer Diaz met with victim who advised that she arrived and attempted to enter the restaurant (Mesa Street Bar and Grill) to attend a luncheon for Carl Robinson. The victim stated she walked to the door and suddenly the offender stepped in front of her standing between the victim and the front door. The offender then began to shout something to the effect of "WHO INVITIED YOU!" and YOU'RE NOT INVITED in an aggressive manner. The offender suddenly with her finger (unknown hand) poked the victims left arm (near the bicep), causing pain to the victim. The victim stated she desired prosecution and a report. The victim stated that she knows the offender as " lily Limon" but no other information. The victim arrived at the Westside station with IO-01 (Friend) who stated that she did not witness the incident but knew that something was occurring between the

victim and offender. IO-01 stated that later in the evening she left the luncheon to go to the restroom and when she was returning the offender stood in front of her and continued to yell at IO-01 that they were not invited. IO-01 stated that she was able to move past the offender and was not assaulted. Officer Diaz obtained photos and video that were uploaded to photo transfer. Officer Diaz did not observe any major injuries to the left arm. Officer Diaz advised Sgt. Kennedy of the incident.

Detectives C. Herrera #2458 and B. Rodriguez #2348 were called out by Sgt Perea #2032 to investigate the listed incident. Detectives were informed they would be assisting S.I.U with the investigation.

2050 hrs

Detectives Herrera and Rodriguez met with Sgt. Perea at the WSRCC. Sgt Perea directed the detectives to go to 3800 N. Mesa (Mesa Street Grill) to attempt and retrieved video surveillance at the business before they closed for the night.

2149 hrs

Detectives met with, John Mendoza () the general manager of Mesa Street Grill. Mr. Mendoza advised he had met with the victim that evening, who wanted to know whether they had cameras. Mr. Mendoza advised the victim stated she had been harassed by another female at the party. Mr. Mendoza advised she allowed the victim to review the video surveillance and allowed her to record it on her cell phone.

Mr. Mendoza allowed the detectives to review the video surveillance from the listed business. Mr. Mendoza advised he did not know how to make a recording of the video and allowed the detectives to record the video using their camera. Detectives recorded approximately a minute of video surveillance on their camera.

2230 hrs

Detectives met with Sgt Perea at the WSRCC and made a DVD recording of the recording on their camera. Sgt Perea advised S.I.U no longer needed their assistance and they would be handling the rest of the case. Detective Herrera generated a supplement to document their actions during this investigation.
